

**DOWNTOWN SUMMERLIN BIG LEAGUE WEEKEND Instagram Giveaway**

**OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN IN THIS PROMOTION AND A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** The Downtown Summerlin Big League Weekend Instagram giveaway (the “Promotion”) is open to all legal residents of the United States who are eighteen (18) years of age or older. Void where prohibited by law. Individuals employed by (i) Summerlin Operating Company, LLC (“Sponsor”); (ii) Downtown Summerlin vendors, retail tenants, or licensees; or, (iii) The Howard Hughes Corporation, its affiliates or subsidiaries, or its advertising and marketing agencies; and such employees’ immediate families, may not enter or participate in the Promotion.
