**Eligibility.** The Sweepstakes is open only to residents of, and physically located within, Summerlin, who are at least eighteen (18) years of age or older and the age of majority in their local jurisdiction as of the date of entry. All directors, officers and employees of Sponsor and its parent companies, subsidiaries, affiliates, sales representatives, distributors, licensees, agents, advertising and Sweepstakes agencies, and each of their immediate family members (spouses, parents, children, and siblings and their respective spouses), and those living in the same household as each, are not eligible to participate in the Sweepstakes. Each potential winner will be notified by email (as applicable) submitted with the potential winner’s entry form. Each potential winner may be required to execute and return an affidavit of eligibility/liability release and, where lawful, a publicity release within 48 hours of date of issuance.
